### **Scholarship Overview:**

**The Chartered Property Casualty Underwriters (CPCU) Society** is a community of credentialed property and casualty insurance professionals who promote excellence through ethical behavior and continuing education.

The Society's more than 28,000 members hold the Chartered Property Casualty Underwriter (CPCU) designation, which requires passing rigorous undergraduate- and graduate-level examinations, meeting experience requirements, and agreeing to be bound by a strict code of professional ethics.

Founded in 1944, the CPCU Society's mission is to "meet the career development needs of a diverse membership of professionals who have earned the CPCU designation, so that they may serve others in a competent and ethical manner."

The CPCU Society has recognized that the leaders of tomorrow are in the classrooms of Morgan State University today. Thus scholarship opportunity is being provided to help students advance their career in the insurance industry. Participation in this program will give students an edge among their peers providing access to professional development and global networking opportunities with CPCU members leading the industry.

## Eligibility Criteria:

- a member of an underrepresented group in the insurance field
- Enrolled or accepted as a full-time undergraduate at Morgan State University in any of the targeted major options.
- Must have a GPA of 3.0 or better.
- Must prove completion of or current enrollment in at least one insurance or financial services class ( ACSC 130, ACSC 346, FIN343, FIN 344, FIN 422, BUAD 361, BUAD 362)
- Attend all CPCU program college events
- Submission deadline: 2/15/2019

Targeted Majors: Accounting, Actuarial Science, Business Administration, Economics, Finance, Math/Stats, Management, Information Systems (Other majors maybe considered on review ).

## Benefits to Scholars:

- MSU-CPCU Scholarship for the spring 2019 semester in the amount of \$1000 (The Insurance Roundtable of Baltimore will match again this year and we have an additional organization, Insurance Society of Baltimore, who will also match for a total of \$3,000)
